The lowa Department of Education used three groups representing a broad spectrum of stakeholders. Each group meets regularly to discuss and develop priorities for the use of funds and the types of activities to be supported.

The Special Education Advisory Panel (SEAP) which has representatives from general education, private providers, parents, special educators, representatives of LEAs and others held meetings in 2023-24 on 9/7-8/23, 10/13/23, 11/17/23, 1/12/24, 2/23/24, 4/5/24 and 5/10/24. During 2024-25 meetings have been held on these dates: 9/18-19/24, 10/18/24, 11/22/24, 1/10/25 and 2/28/25, with additional meetings currently scheduled for 4/11/25 and 5/16/25.

Representatives from all 9 intermediate units (Area Education Agencies) provide input and prioritize needs based on the activities to be supported in their agencies by Part B funds. This group meets and gathers input from LEA staff and others in their respective regions to provide to the state level at scheduled meetings usually monthly. This group includes the Area Education Agency's Administrative staff including the Chief Administrator, personnel from other divisions of the Agency including Special Education, Educational services, Area Education Agency School Business Official and Media and Technology services. These meetings are scheduled on the fourth Thursday and Friday from August through May. Meetings during 2023-24 were held on 8/24-25, 9/14-15, 10/19-20, 11/15-16, 12/14-15, 1/18-19, 2/15-16, 3/21-22, 4/18-19 and 5/16-17. The 2024-25 meetings were held on or are scheduled for 8/22-23/24, 9/26-27/24, 10/24-25/24, 11/21-22/24, 12/19-20/24, 1/23-24/25, 2/27-28/25, 3/27-28/25, 4/24-25/25 and 5/22-23/25.

Additionally, the Department uses input from school business officials. This group meets quarterly.

The lowa Department of Education staff combined the input from these broad-based stakeholder groups in a workable plan for the use of Part B funding in Iowa.


Total Amount of State Financial Support Made Available for Special Education and Related Services for Children with Disabilities

B. Significant Disproportionality
