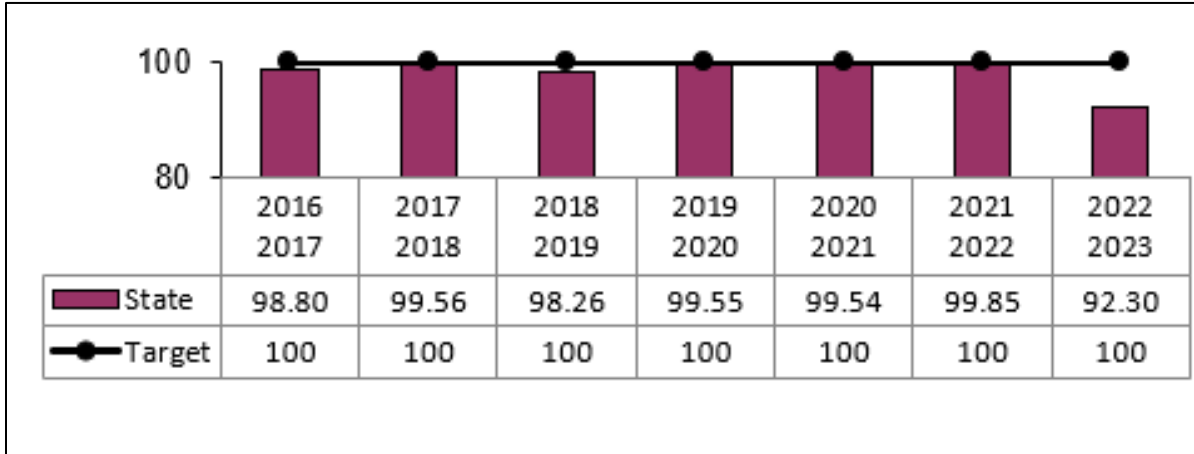

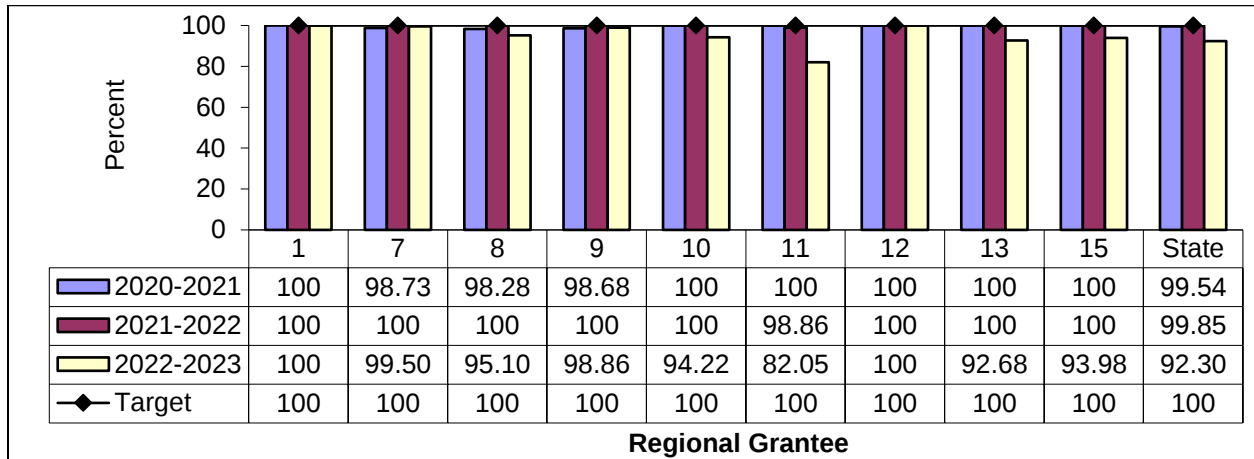


**Indicator C1:** Regional Grantee Percent and Number of Children Receiving Timely and Untimely Services, by Regional Grantee.

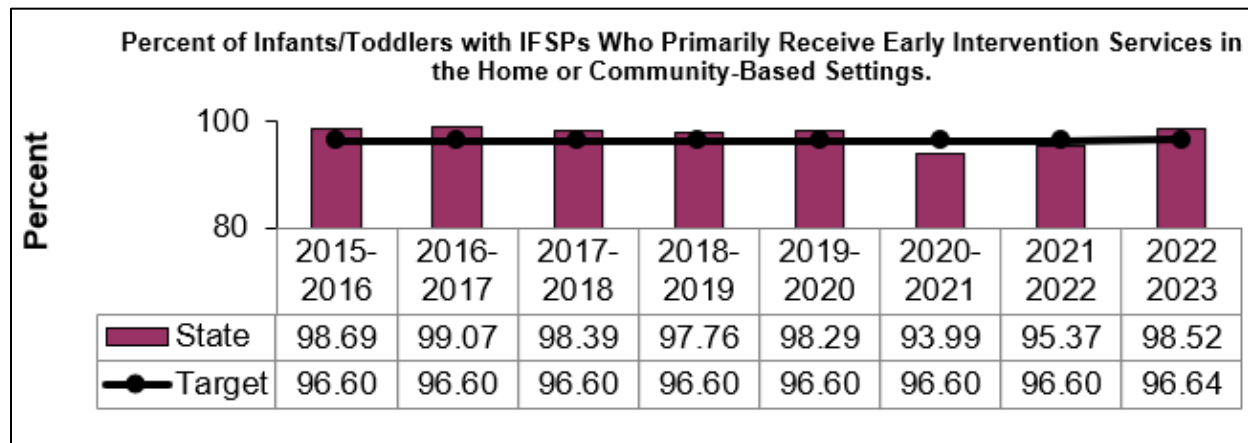

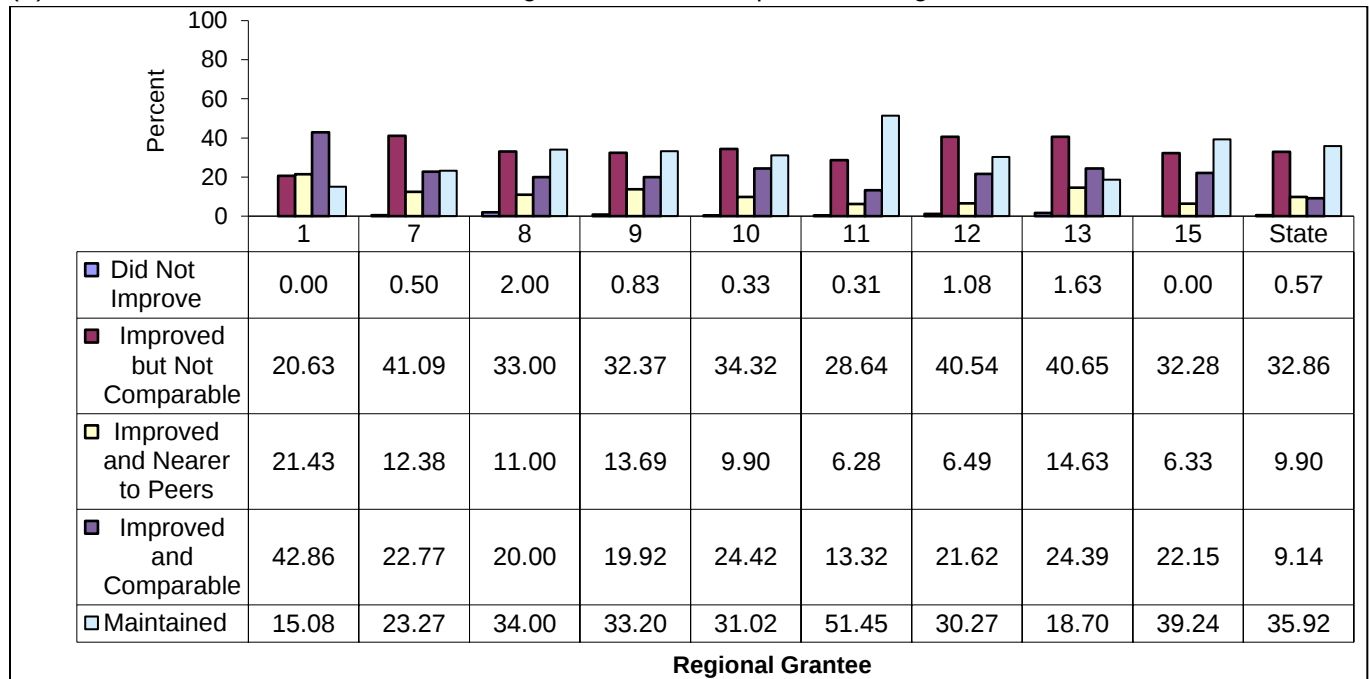

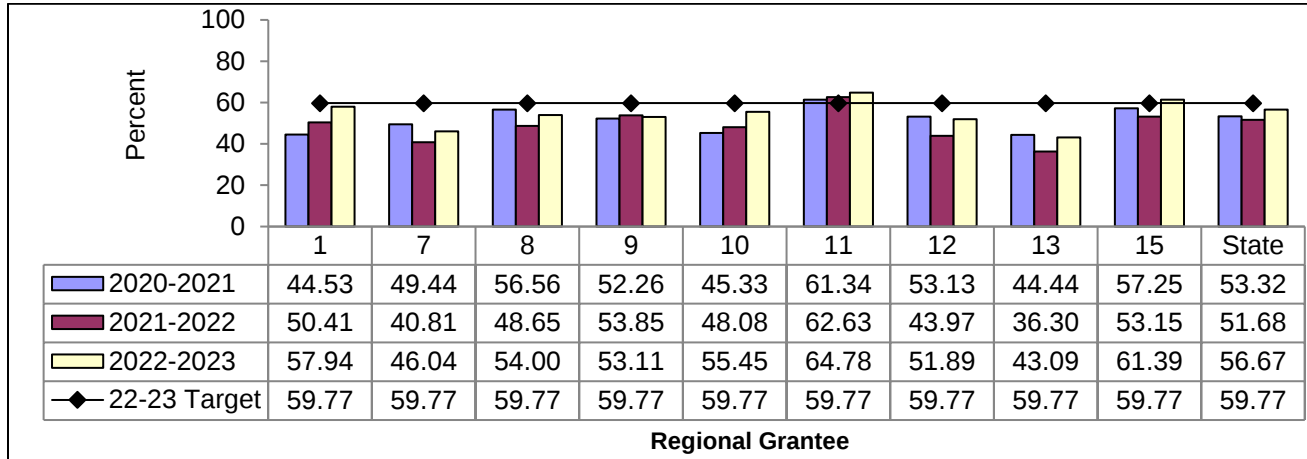

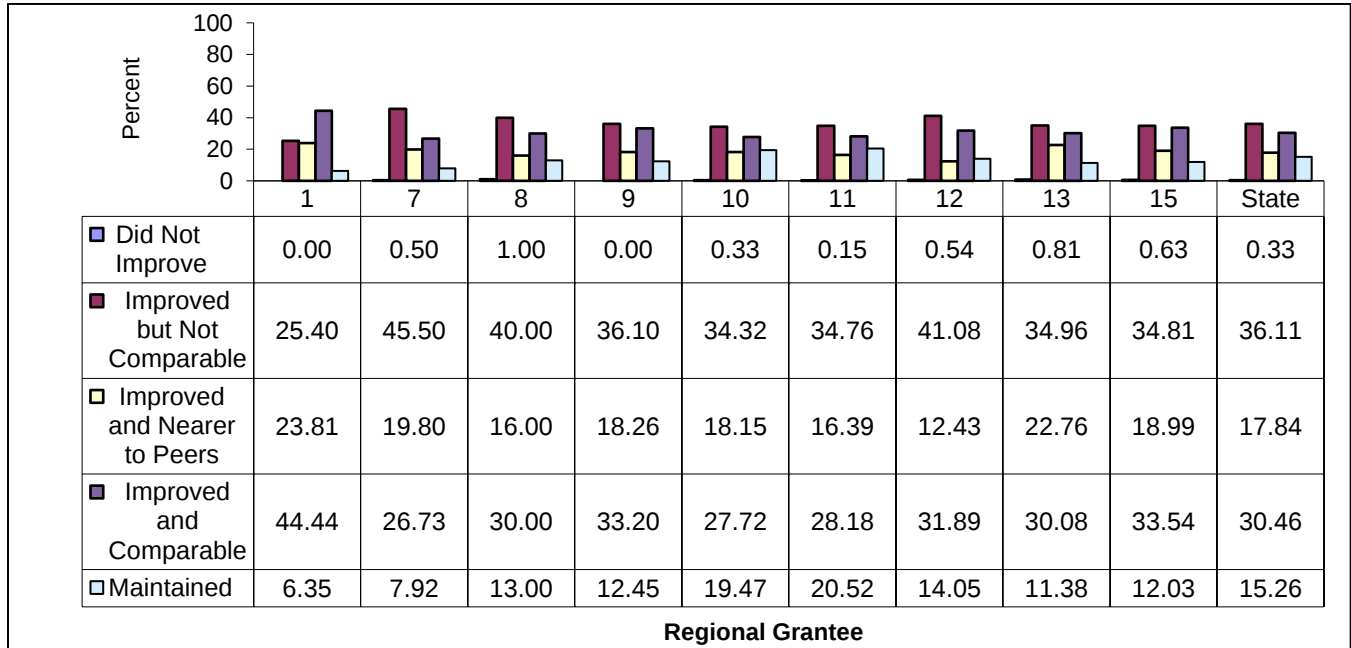

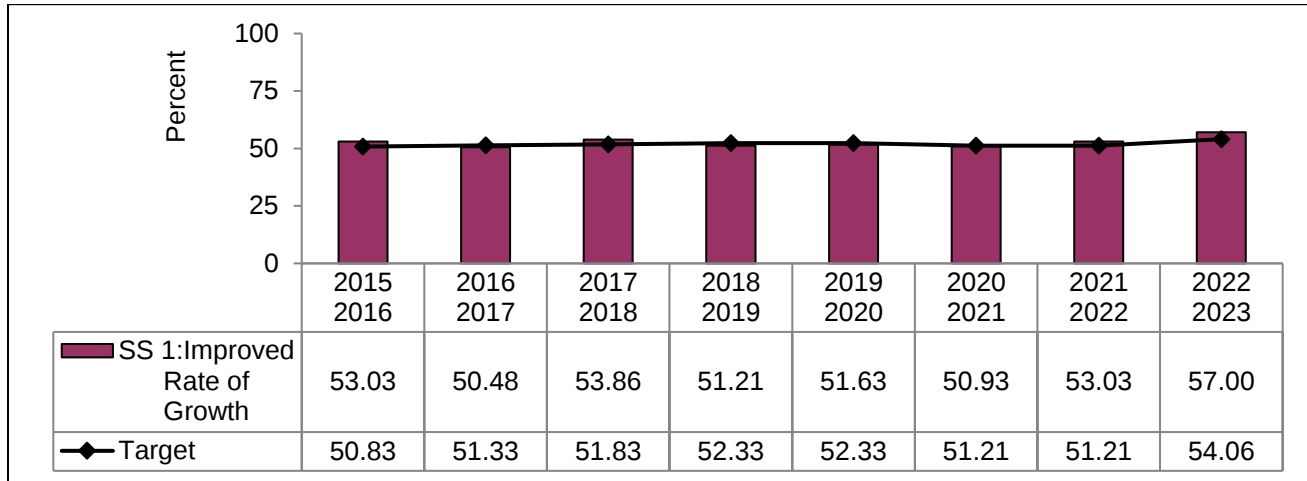

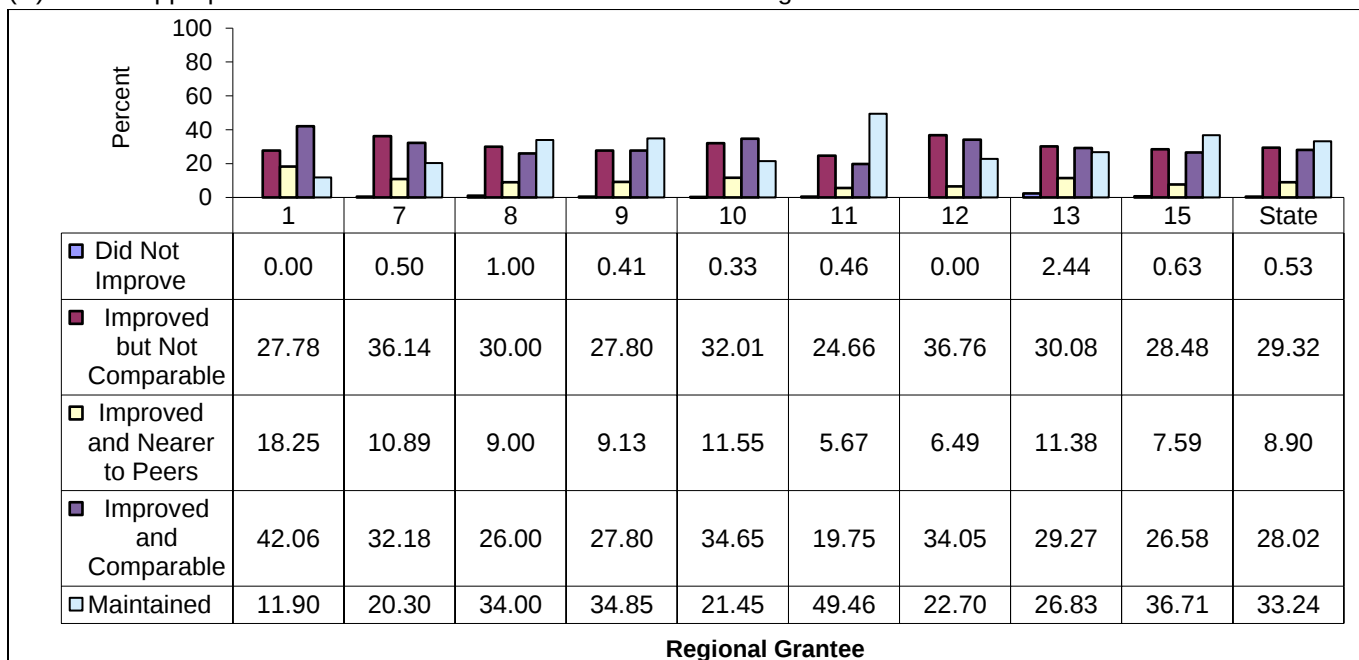

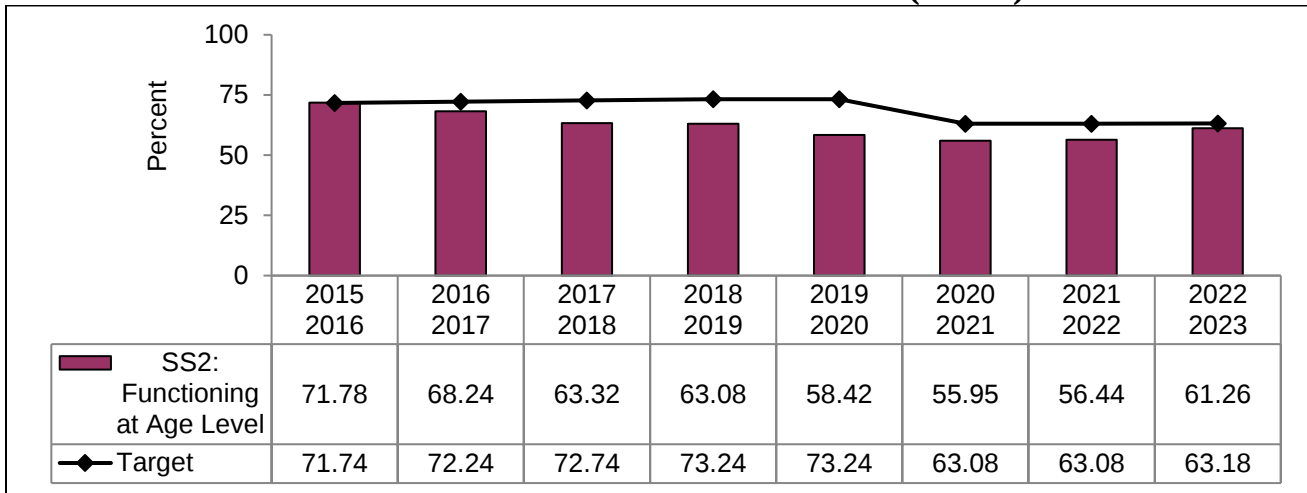

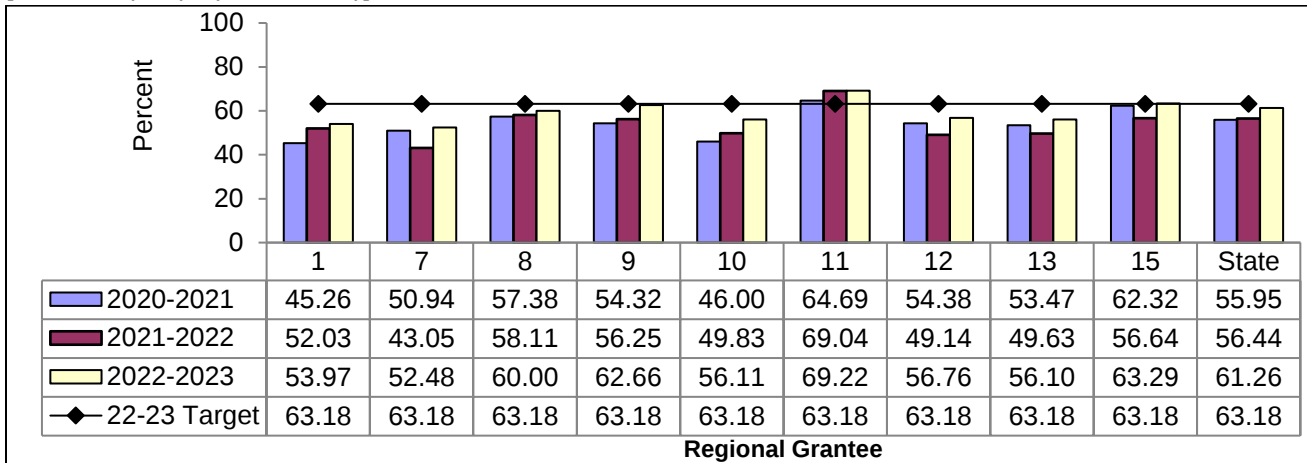

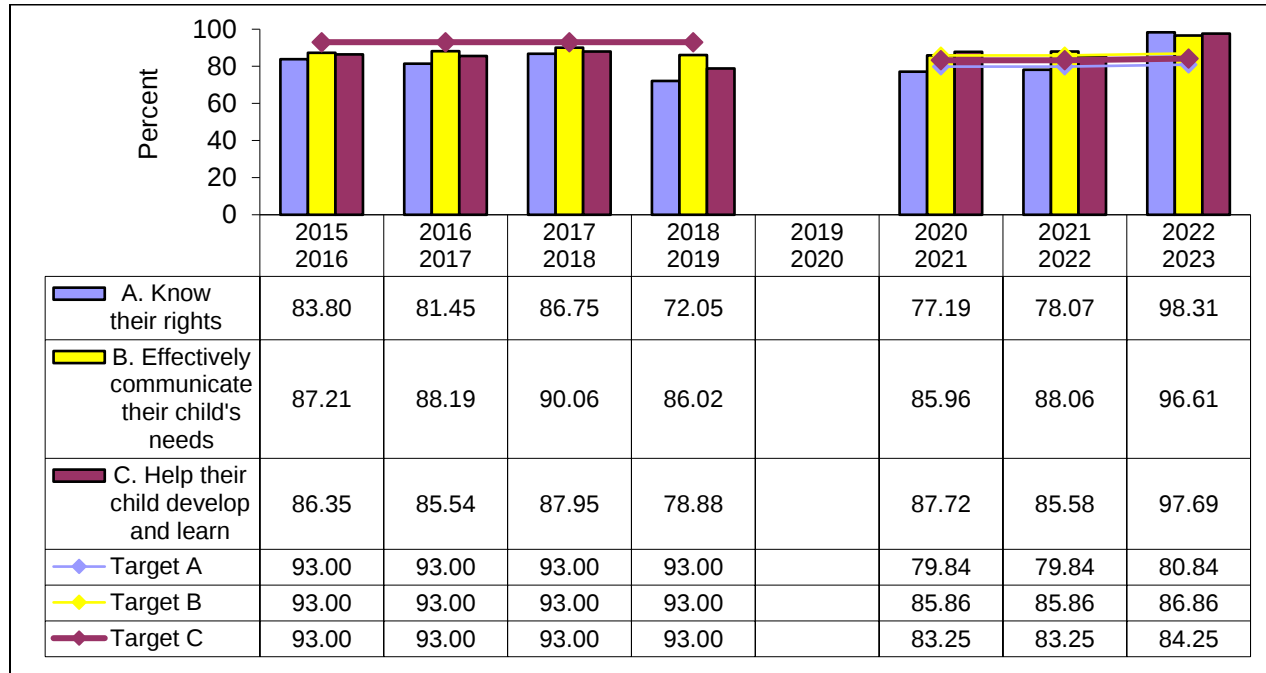

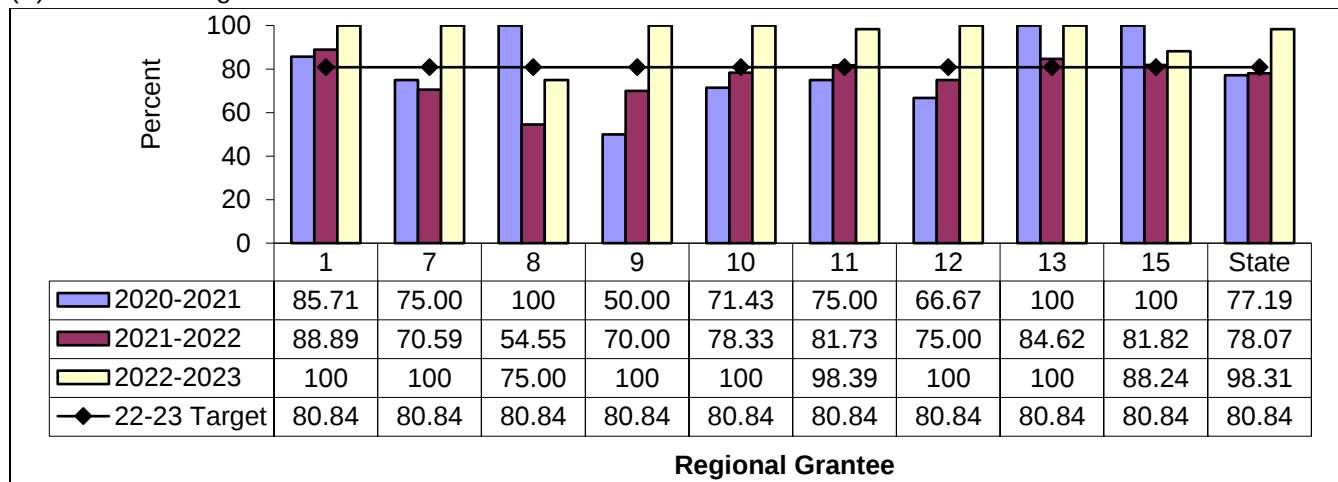

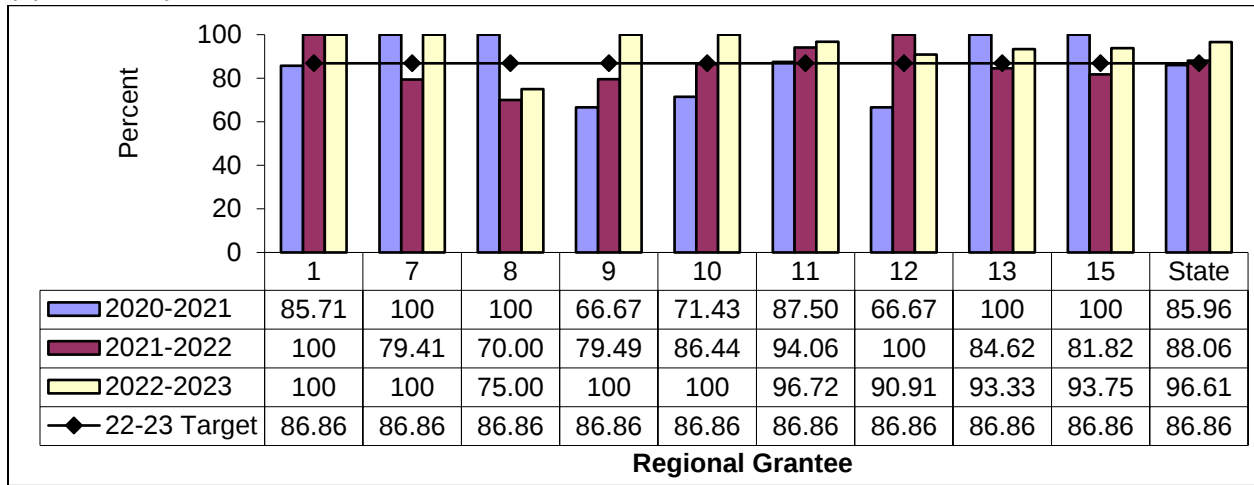
**Indicator C4A: Regional Grantee Data for Percent of Families Reporting that EIS Helped the Family**

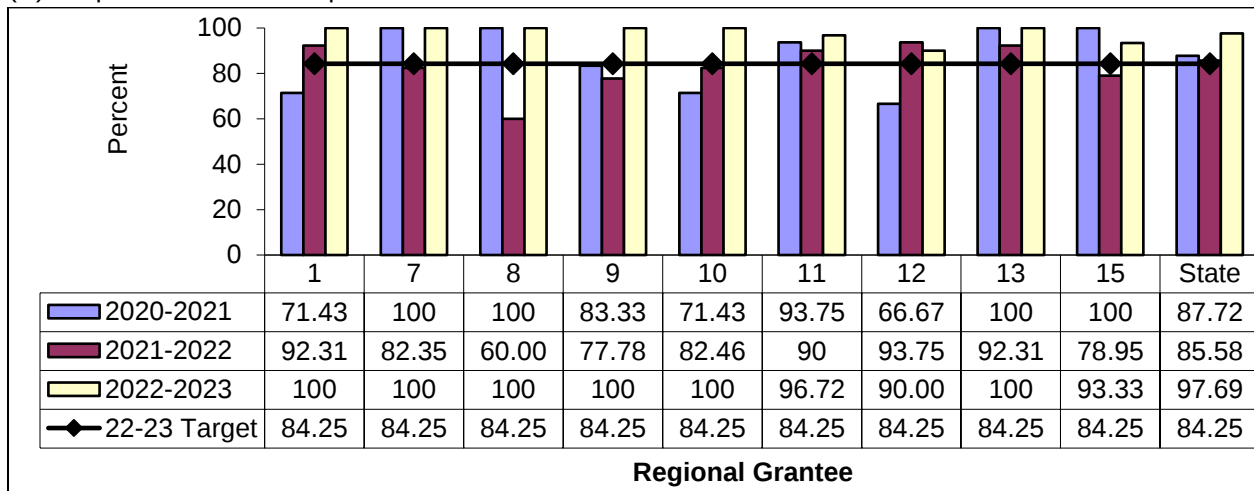

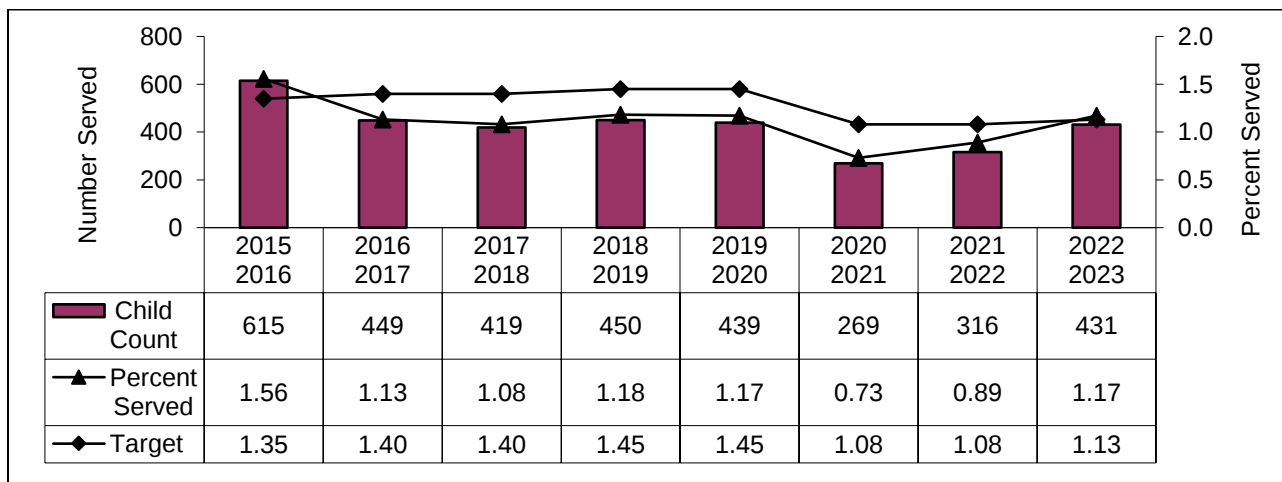

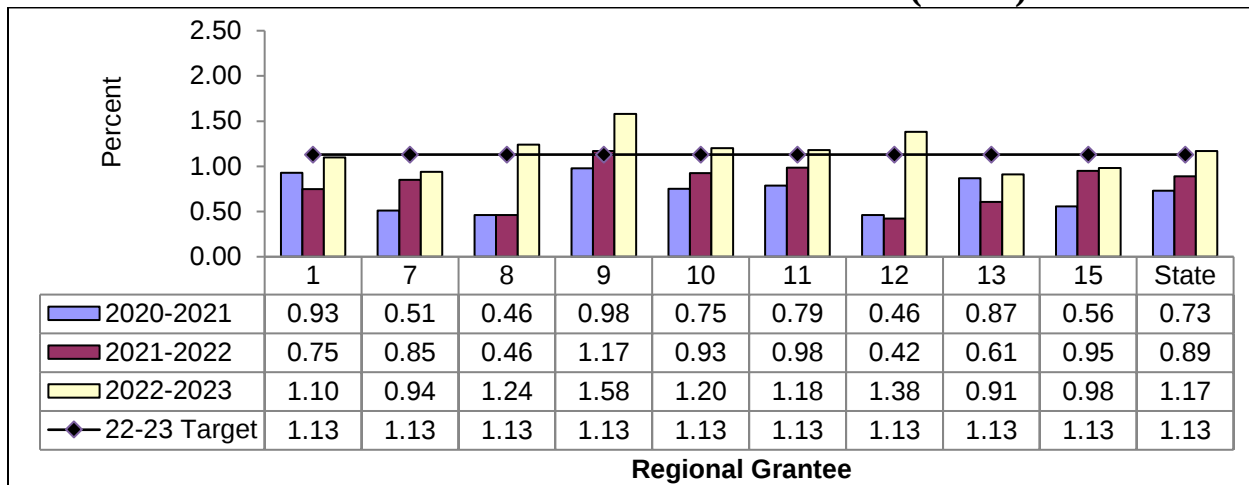
**Indicator C5: Child Find (Birth to One).** Percent of infants/toddlers birth-1 with IFSPs compared to national data.

**Indicator C5:** Number and Percent of Infants Birth to One with IFSPs.

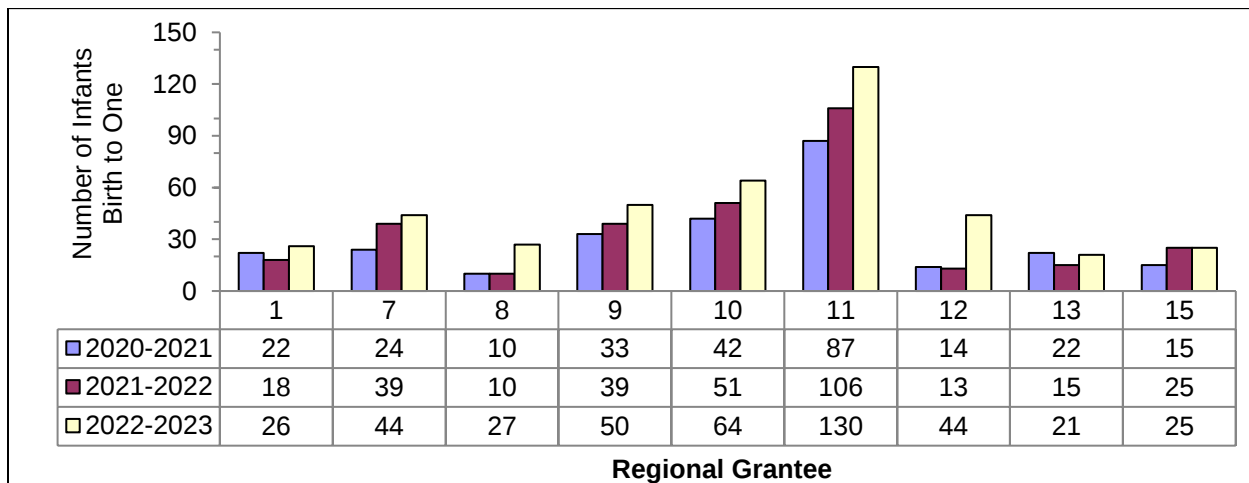


**Indicator C5:** Percent of Infants Birth to One with IFSPs, by Regional Grantee.

**Indicator C5:** Number of Infants Birth to One with IFSPs, by Regional Grantee.

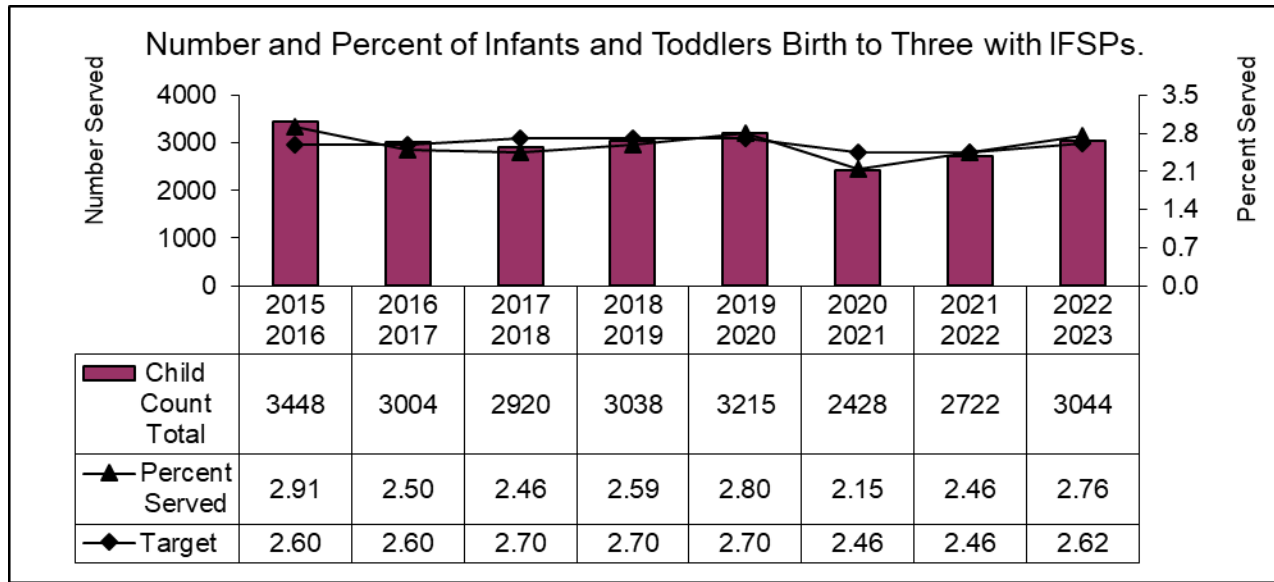

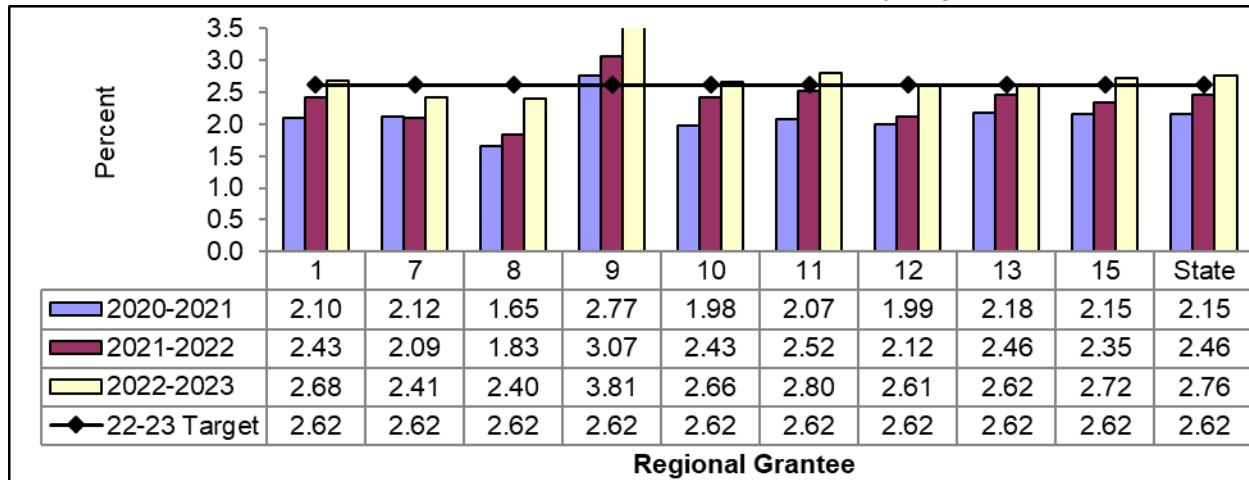

**Indicator C6: Child Find (Birth to Three). Percent of infants/toddlers birth-3 with IFSPs**

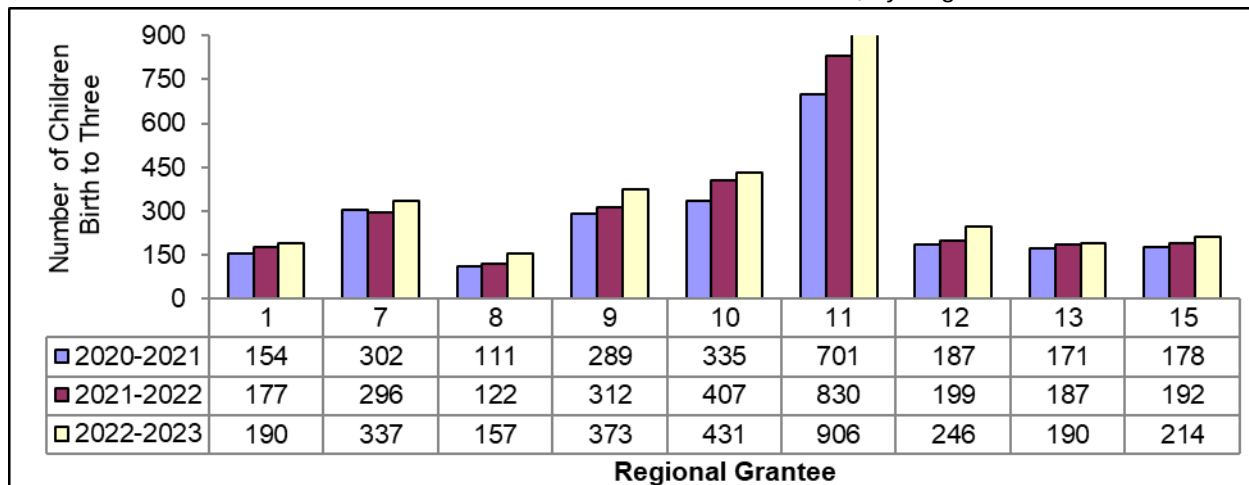

**Indicator C6:** Percent of Infants and Toddlers Birth to Three with IFSPs, by Regional Grantee.

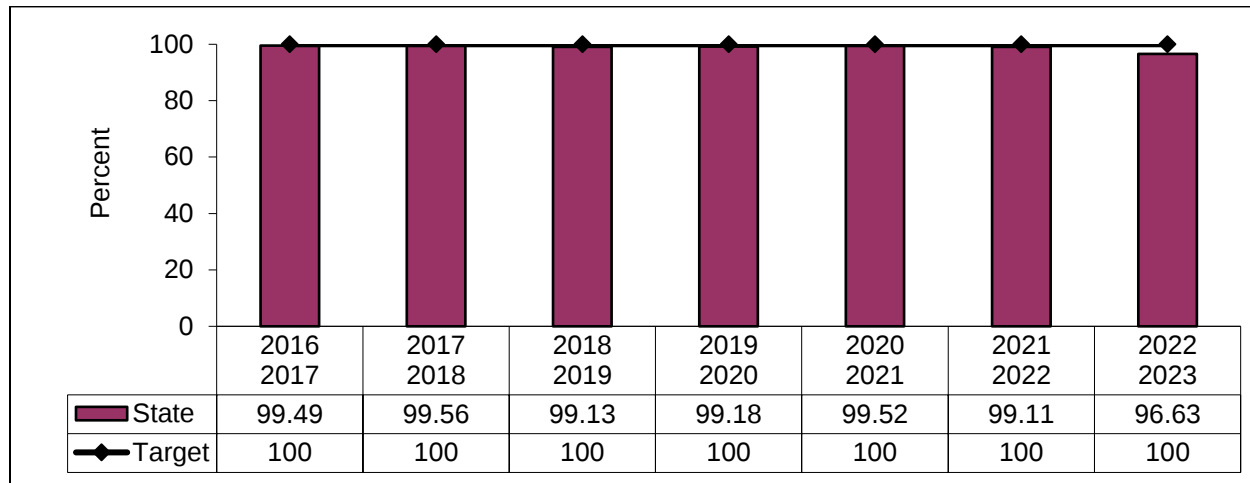


**Indicator C6:** Number of Infants and Toddlers Birth to Three with IFSPs, by Regional Grantee.

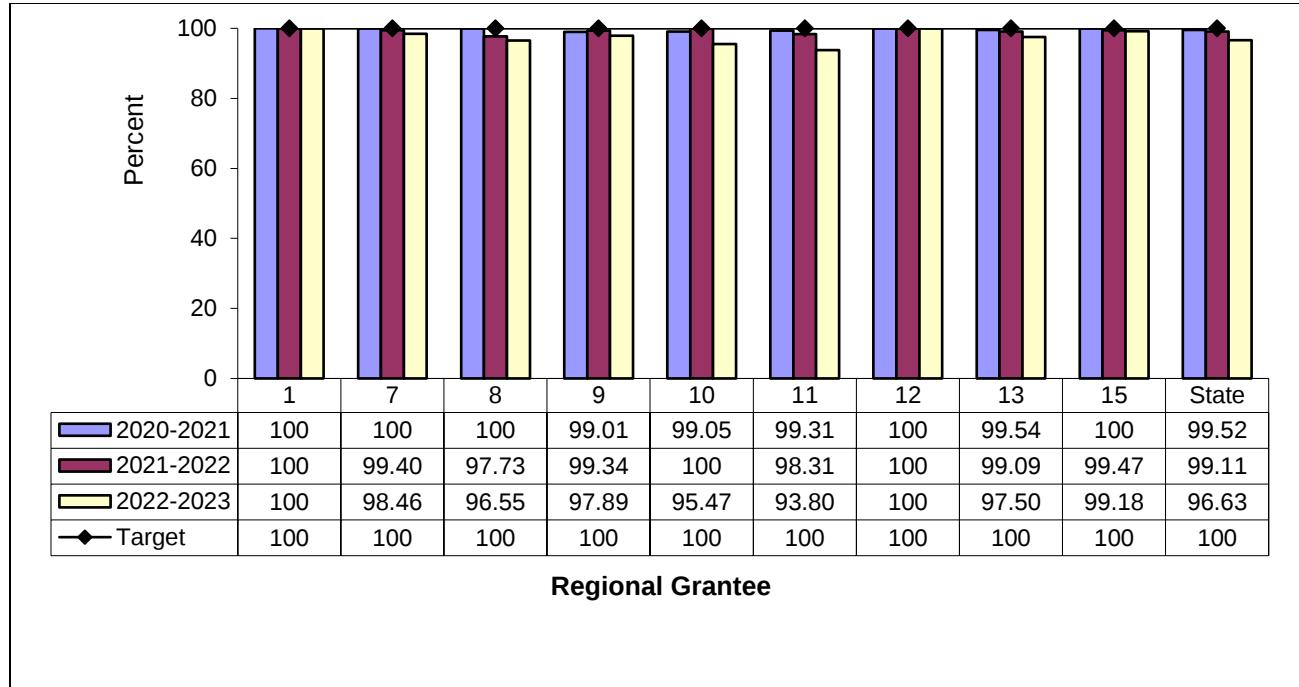

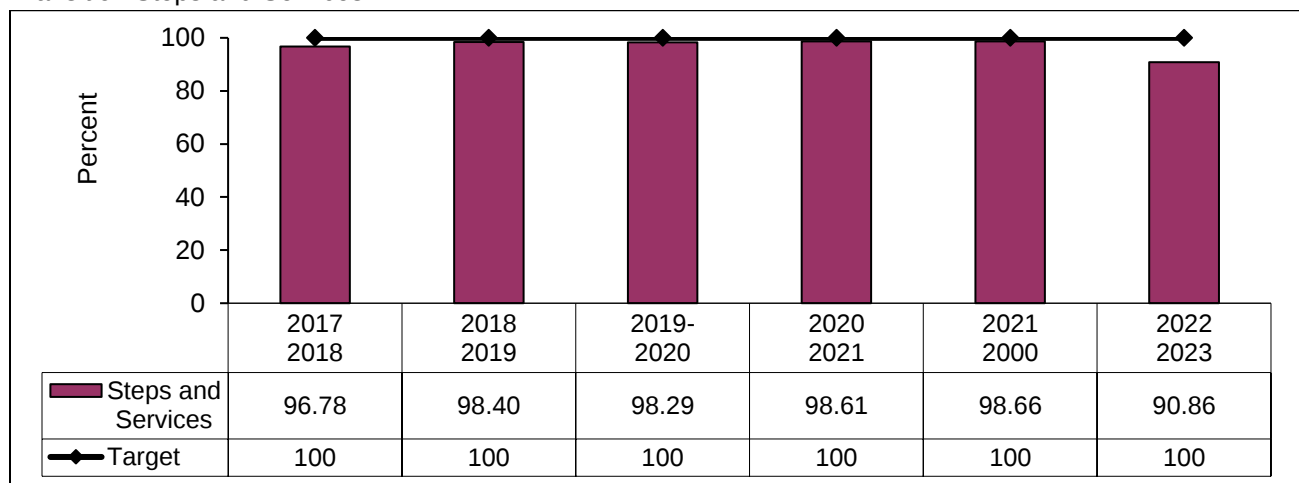

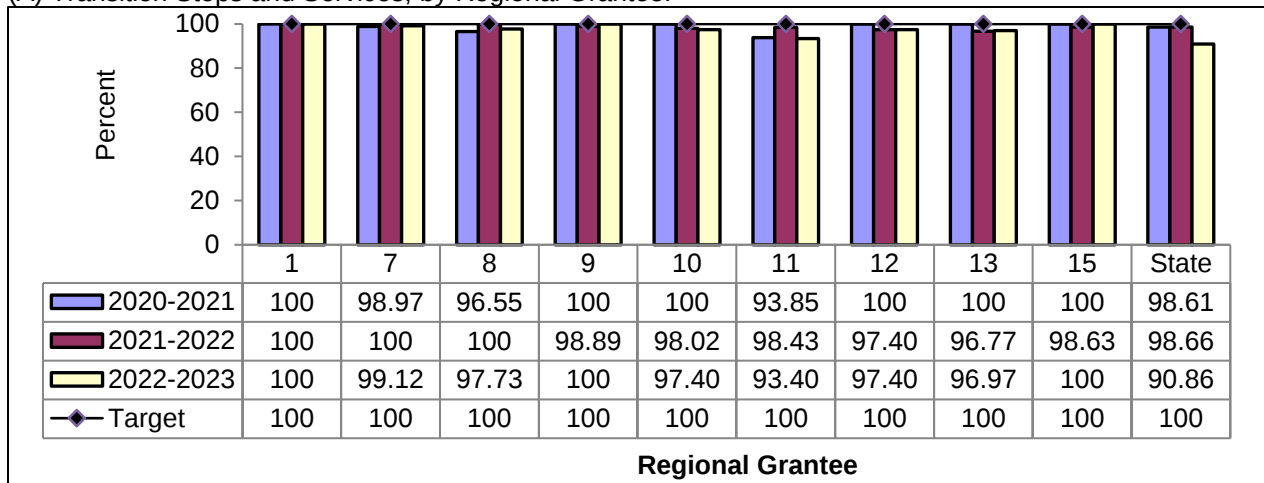

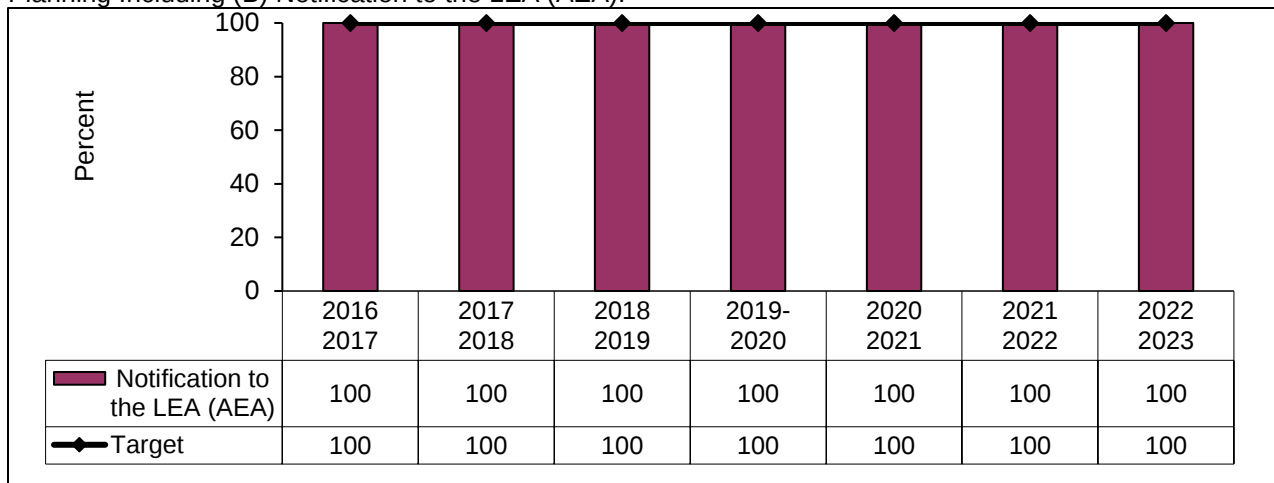

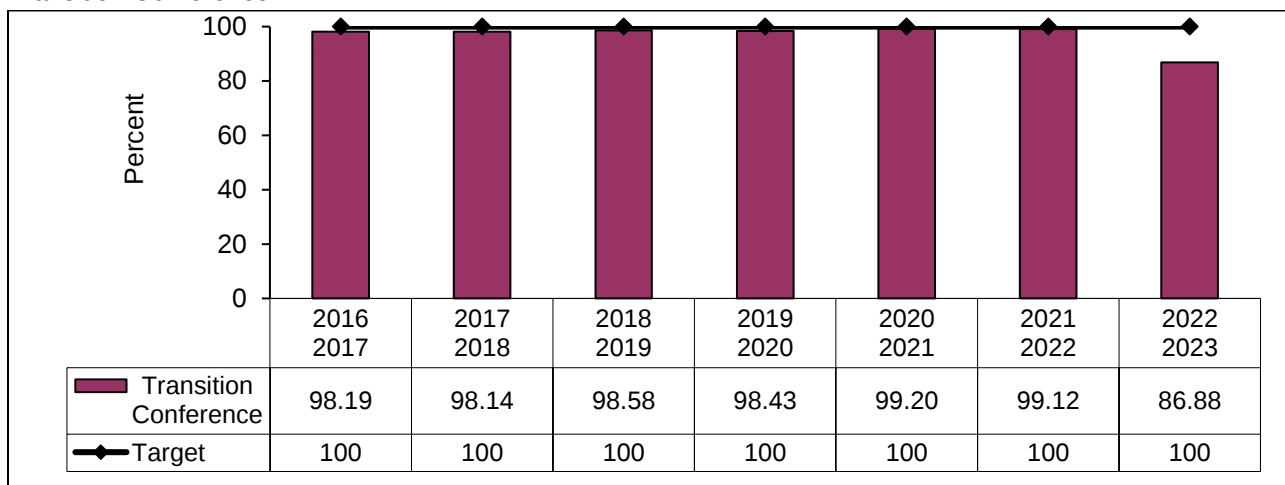
