Fiscal Year 2024 (FY24) Progress Report: Workforce Training and Economic Development Fund

The Workforce Training and Economic Development (WTED) Fund was established by the Iowa Legislature in 2003 as part of the Grow Iowa Values Fund (Iowa Code 260c.18A), and receives monies from the Iowa Skilled Worker and Job Creation Fund. The WTED fund has become an important source for financing community college career and technical education for new program development, innovation and capacity building.

The WTED Fund is allocated annually, using the community college state general aid distribution formula, as defined in Iowa Code. The WTED Fund requires 70 percent of appropriated monies be used to support projects, programs and initiatives that fall within Iowa's targeted industry clusters. These program clusters are defined as: advanced manufacturing, information technology and insurance and alternative and renewable energy and life sciences, which include the areas of biotechnology, health care and nursing technology (Iowa Code 260c.18A).

Each community college is required to provide the Iowa Department of Education (Department) and the Iowa State Board of Education the opportunity to review and comment on their proposed use of WTED funds (281 IAC 27). To ensure accountability, each institution must submit an annual progress report and plan to the Department by September 30, which outlines their use of funds from the past year and proposed uses of the funds for the following year. The annual progress report and plan notes any obligated and planned carryover funds which includes a description for the carryover use. "Obligated" means the college has contracted for a product or service, but has not yet paid the vendor(s).

The colleges can modify their plans for WTED funds as needed during the fiscal year without Department approval, and unexpended monies may be carried over to the next fiscal year for planned projects.

The charts and tables in this report illustrate FY24 WTED expenditures, statistics on WTED-funded program participants and completers and the FY25 plan for each community college.

The Department's Bureau of Community Colleges is responsible for the administration and oversight of the WTED fund. This report outlines the WTED-funded programs, projects and educational activities the community colleges have implemented during the past fiscal year.

Targeted Program Clusters: FY24

Each of Iowa's 15 community colleges submitted progress reports indicating they have fulfilled the required 70 percent threshold for training projects within Iowa's targeted industry clusters.

Aggregate spending in these areas significantly exceeds that benchmark, with 90.3 percent of WTED monies expended in targeted program cluster areas during FY24.

The targeted program clusters are defined in Iowa statute 260C.18A as:

- advanced manufacturing
- information technology and insurance
- alternative and renewable energy
- life sciences, which includes biotechnology, health care and nursing technology

The advanced manufacturing and nursing program clusters account for 57% of program spending. Although Iowa Code allows for 30% spending on non-targeted clusters, community colleges focus funding on targeted industries with over 90% of funds allocated to targeted clusters.

Participants and Completers: FY24

Each training program has individual requirements and timelines for completion. Participant and completer numbers include both long- and short-term programs. Each community college determines which programs are supported by WTED funds, so wide variations in participant and completer data are possible. In addition, participants in FY24 may not complete until FY25 and some FY24 completers may have been counted as participants in FY23. In FY24 the WTED funded projects yielded:

- 80,036 total participants, of which 7826 (10%), were high school students participating in *career academies*
- 65,138 total completers which included nearly 40,000 (61%) completers involved in *business and industry training or retraining* at 730 businesses across the state
- 2,719 total businesses were supported of which 1,255 (46%) were identified as *small businesses/entrepreneurs*
- 27,468 students (34%) participated in *career and technical education programs* that received WTED funds
